The finalized question papers have been handed over to DCEB Secretary pertaining to the Districts for under taking printing and conduct of School Assistant-II examinations. The District Educational Officer are requested to verify the edited question papers and take up the printing as per the procedure in vogue. The District Educational Officers of the erstwhile districts are requested to take up the printing of the question paper for all the New District formed in the main District. A set of the printed question paper shall be submitted to Director SCERT in a sealed cover without fail.
